Your application dated August 4, 2022 for Parts Manufacturer Approval (PMA) was processed via the streamlined process defined in the Memorandum of Understanding between Aircraft Lighting International and the FAA, revision A dated November 5, 2019. In accordance with the provisions of Title 14, Code of Federal Regulations (14 CFR), part 21, Certification Procedures for Products and Articles, subpart K, the FAA has found that the design data, based on test and computation, submitted with your letter dated August 4, 2022, meet the airworthiness requirements of the regulations applicable to the products on which the articles are to be installed.
